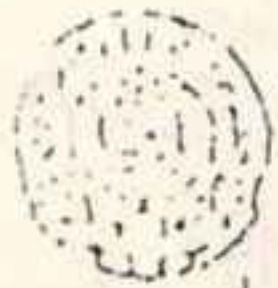

Under communication No. HCC-3935/9340-III-2 dated 3-10-1985, the Education Department, Government of Maharashtra had informed the University that the Government had no objection to the University processing the proposal as per Section 43(4) of the Act and directed the University to process it further as per Section 43(5), (6) etc. The same has been complied with. While doing so, in the absence of information regarding subjects and courses actually taught during 1985-86 the proposals as recommended by L.I.C. (Local Inquiry Committee) for teaching during 1985-86, have been conveyed to the Government, attention to which has been received under Govt. letter No. HCC-1005/122665(9368) III-2 of 16-1-1986.

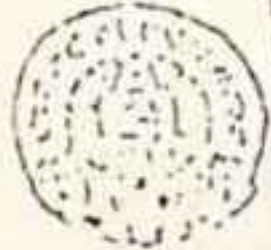

When compared to the proposal for 1935-36, the above details are found to be in order and so merit favourable consideration.

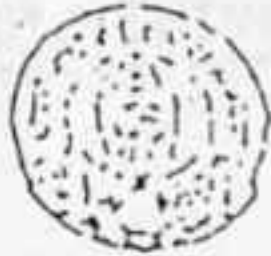

Under letter No. UWF-1086/45/86/UNI-2 of June 13, 1986, the  
Education Department, Government of Maharashtra, conveyed its no object

(2)(a) Extension of affiliation :

B.H.Sc. Part II (Semesters III & IV), one vision of Marathi medium. The details of subjects proposed to be taught are shown in the application. These subjects are in accordance with the syllabus.

About 30 students have been enrolled to B.H.Sc. Part I Course during 1986-87, and the authorities of the college expect very good results. The proposal for extension of affiliation of B.H.Sc. Part II (Semesters III & IV) - One division of Marathi medium - is as a result of natural growth and development and hence, it is felt, merits, favourable consideration.

(b) Extension of Affiliation of One Division of B.H.Sc. Part I  
(Semesters I & II through English Medium): *with same subjects as for B.H.Sc. Part I - Marathi Medium -*

More than 60 students had applied for admission to the B.H.Sc. Part I Course for the academic year commencing from June 1986. However, in the absence of timely permission, the authorities of the College could not consider all of them. As the permission was received by the College almost around the commencement of the academic year 1986-87 a good number of these students joined some other colleges, with the result that the authorities of the college could actually admit about 30 students.

There is no institution offering a degree course in Home Science in the whole of Nashik region, i.e. Nashik, Nagar, Jalgaon and Dhule Districts. However, the SMRK College of Gokhale Education Society has an added advantage of Students' Hostel. The authorities of the College will be able to provide hostel facilities to about 50 students during 1987-88 and to 50 more during 1988-89, as plan for building of a hostel for 100 students has been sanctioned. At present there is built up accommodation in the campus of the College where about 30 students can be accommodated. This number will be in addition to 50 students to be accommodated in the new hostel to be built in 1987.

Nashik and its surrounding area have been developing industrially and one of the special features is a number of industries with foreign collaboration having non-marathi speaking employees who are large in number. The industrial class<sup>in</sup> general, and the managerial class in particular, need for their children English as the medium of instruction as their mother-tongue is other than Marathi. The request to start a degree course in Home Science through English medium is increasing. In view of it the authorities of the College are confident of enrolling about 50 to 60 students to B.H.Sc. Part I Course through English medium during 1987-88.

The authorities of the College have engaged services of qualified staff to teach Home Science Course.

The College has a munificent building providing for laboratory and other necessary physical facilities as prescribed by the University for a degree course in Home Science. The subjects will be same as for B.H.Sc. Part I Course (through Marathi medium which are already being taught).

In view of the position stated above the proposal to start one division of B.H.Sc. Part I Course through English medium during the academic year 1987-88, merits, it is felt, favourable consideration.

The above mentioned proposal of affiliation of the College for the Academic Year 1987-88, was placed for consideration of the Executive Council as per Section 44 of the Act at its meeting held on February 1987. The Executive Council by its Resolution No.18, decided that the proposal be forwarded to the Government, as per the procedure laid down in that behalf.

B.Home-Science Part I Class through English medium - one division for a period of one year from June 1987.

Provided that the Sponsoring Society of the College viz. The Gokhale Education Society, Nashik gives a written undertaking to fulfil the conditions as stipulated in the attached report of the Inquiry Committee as also given herebelow and fulfils them in the manner required, to the satisfaction of the Executive Council within the time schedule, if any, stipulated thereat.

- (c) All appointments including those of the Principal, Lecturers and others, shall have to be got approved by the Management in advance, from the University.
- (d) All appointments of the teaching staff including that of the Principal, will have to be made, after duly advertising the posts and the selection for the appointments to these posts will have to be made as per New Statute 13 of the University.
- (e) The salary scales of the teaching staff will be in accordance with what is laid down by the U.G.C. State Government and the University for the purpose.
- (f) The Teacher-pupil ratio should be maintained according to the directions of the University.
- (g) The workload for the lecturers and other teaching staff shall be in accordance with the rules fixed from time to time by the University and the Government. No material deviation from the above rules will be permitted unless a sanction to that effect is obtained by the Society/College in advance, from the University.
- (h) The College shall provide definite periods in each subject for the lectures, practicals and tutorials etc., as prescribed by the University.

E. Non-Teaching Staff

(a) The College should appoint non-teaching staff as per norms laid down by the State Government and the University.

(b) The salary scales for supervisory staff, clerks and peons should be in conformity with the scales prescribed by the State Government and the University.

F. Medium of Teaching

(a) The medium of instructions for the Home-Science Course shall be English and Marathi at B.H.Sc. Part I Class and Marathi at the B.H.Sc. Part II class as agreed to by the Management.

(b) The College of Home-Science should not start instructions through any medium, in any class, other than the one for which an application is made, without prior written permission from the University.

G. The starting of the classes will be subject to following further conditions :

(a) The college will not start the class of B.H.Sc. Part I till the norm of minimum enrolment as laid down by Government is fulfilled.

(b) The Management will give an undertaking to the University to the effect that for the B.H.Sc. Part II Class started by it in the academic year 1987-88, it will take upon it as a committed liability at its own expense the continuation of the B.H.Sc. Part III Class for that batch irrespective of enrolment in 1988-89.



(c) The College authorities will within a month from the commencement of the class submit to the University a detailed time-table, the names of teachers, and the time when the classes are held. The rules laid down by the University regarding attendance and internal assessment will be strictly adhered to by the College.

The University may at its discretion ask the Committee or any of its members to visit the College to observe the functioning of the Home-Science wing.

H. Library Requirements

The College will purchase books for the library at the Home-Science College worth Rs.10,000/- during the academic year 1987-88.

I. Additional equipment and furnishings that will be required in view of the B.H.Sc.Part II Class and one additional division through English medium were pointed out by the members of the Committee to the Management. The Management should comply with these as early as possible, but before the commencement of the next academic year.

J. Fee Schedule

The College will adhere to the Fee Schedule as directed by the University from time to time.

K. Reserve Fund

The Management will maintain the stipulated Reserve Fund for its Arts & Commerce College and separately for the Home-Science wing as laid down in the rules of the University.





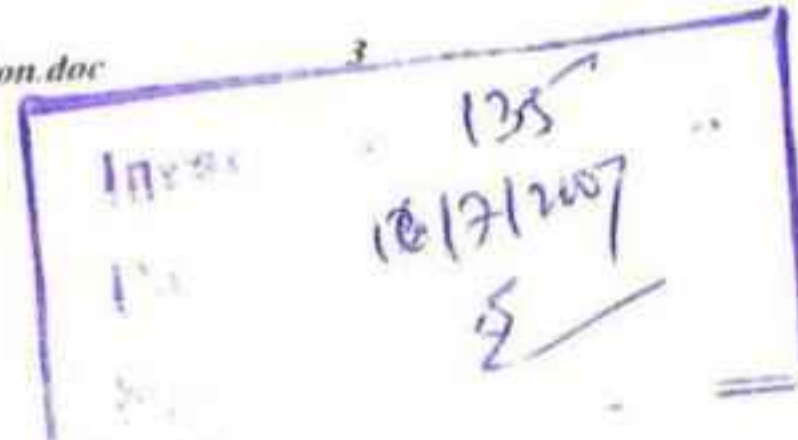
